Re: **Christmas Holiday Activities Programme** 

I'm pleased to announce that we will be running another holiday activities programme during the Christmas holiday period. This Christmas the activities are based at Coopersale Hall and Oaklands.

The choices available are as follows:

Course 1: Multi-Sports

Age Range: Current Reception to current Year 6

Staff: Ultrasport coaches led by Steve Grenfell, sports coach at Coopersale Hall. Steve has

run our sports clubs and holiday activities for many years and is supported by a team

of qualified coaches who know our children.

Venue: 1 week at Coopersale Hall and 1 week at Oaklands

Cost: £20 per day with the option of a minimum of 3, 4 or 5 days per week

Numbers: Between 25 and 30 children per session with 2 or 3 coaches (depending on numbers)

Content: The days will concentrate on improving general skills and there will be many small-

> sided matches and tournaments with prizes awarded at the end of the week. The activities include short-tennis, rounders, basketball, hockey, football and cricket.

Course 2: **Early Years Sessions** 

Age Range: Current Lower Kindergarten to current Reception

Staff: A team of qualified key workers from the Oak-Tree Schools, all of whom are used to

working with Early Years children in their own settings within the appropriate ratios

of staff to children and planning for a range of fun and creative activities.

Venue: 1 week at Oaklands

Cost: £25 per day with the option of a minimum of 3, 4 or 5 days per week, or £110 for a

full week

Numbers: Between 15 and 20 children per session with 3 or 4 keyworkers

Content: The days will be planned according to the EYFS Curriculum and activities will include

arts and crafts, messy play, outside play, science and cooking, story-telling and much

more.

Sessions: Course A: Monday 16 to Friday 20 December held at Oaklands

As with previous courses, the days will run from 9.30am until 3.30pm, with additional before and after care from 8.45am until 9.30am and then from 3.30pm until 4.00pm according to demand. As usual, these additional sessions will be charged at £2 each and payment should be made directly to the staff.

Children will require a packed lunch (please do not include any nuts or fizzy drinks), appropriate clothing and footwear for indoor and outdoor use. Water will also be available from the school drinking fountains. Please make sure that your children do not bring to school any electronic equipment, such as iPads or mobile phones. Instead, they are welcome to bring a reading or puzzle book to read for any breaks during the day.
